Thesis declaration forms

A declaration form must be completed for all soft-bound theses for a [Master's](#)ⁱ or a [PhD](#)ⁱⁱ. This confirms the thesis as the student's personal work and also that this work has not previously been accepted, for any other degree or diploma.

When the final thesis is ready for hard binding, an [Author Declaration](#)ⁱⁱⁱ concerning the consultation, copying and deposit of the work must be completed to preface the Library copy. Restrictions on access may only be granted by the appropriate PVC (thesis for a Master's or Honours degree) or the DVC (Research and Enterprise) and appropriate PVC (PhD theses). Restrictions of use may involve your deposited thesis files.

Making your thesis available to others

By submitting your thesis it will become available for others to consult. Unless otherwise stated the Library may copy all or part of your thesis and provide it to another institution or individual for the purposes of research and private study. Section 56 of *The Copyright Act* covers copying by library staff.

New Zealand [Copyright Guidelines for Research Students](#)^{iv} offer further guidance in dealing with related issues, permissions and procedures.

Your obligations

Using the work of others

You are permitted to use copyright material for 'research or private study', as outlined in Section 43 of *The Copyright Act*.

If your use of copyright material does not fit within 'fair dealing' then you must obtain permission from the copyright owner, i.e. publisher, creator, author; this is known as third-party copyright.

Third-party copyright

Third-party copyright material is owned by a third party from whom you have gained written permission (to use that material). Examples include: a photograph; graph; table; or an article that has been co-authored and/or been published with copyright given to the publisher of the journal. If any part of your thesis is work that you have already published, i.e. journal article and/or conference paper, then you should consult the agreement you have with the publisher. A third-party copyright checklist has been provided to assist you through the stages of creation, submission and making your thesis available.

If you are uncertain whether you need to seek permission to include third-party material please consult your supervisor, check out the [Copyright at Otago](#)^v page and/or email the [University Copyright Officer](#).

Seeking and recording permission

While working on your thesis there are steps you can take to seek permission from copyright owners by contacting them in advance about your *intention* to use their work within your thesis.

When seeking permission to use someone else's material you should detail the material you want to use, how you intend to use it, and ask for their permission to use the material. A letter and/or email are recommended as ways to contact a copyright owner so you will then have a written record of the agreement. You can write a letter including the elements suggested in the [Copyright template letter](#)^{vi}. If the copyright holder permits use of fulltext and/or images in hard copy but not digital copy, advise them that fulltext and/or images can be referenced, but suppressed or removed in the digital copy.

To help record the permissions you are seeking and/or been given an example of a [Copyright permissions report](#)^{vii} has been provided. This report highlights the type of information you must record in order to keep track of what permissions you have sought, and whether you received permission. You can also record this information within citation software such as EndNote.

If permission is not granted

- Reduce the amount of material quoted so that it falls within fair dealing, and reference it
- Paraphrase or rework the material so that it is no longer a direct quotation or duplication, and reference it. Make sure it clearly indicates that the material has been adapted or modified
- Remove the material from the thesis altogether
- If appropriate, replace the removed material with an alternative quotation or extract for which copyright permission has been obtained, and reference it

Thesis deposit and permissions

When you deposit your thesis with the Library, it is important to provide evidence of your thesis permissions. All evidence provided to the Library will be retained, together with the corresponding thesis. If permission to use third-party material has either not been sought or has been refused, *those particular items* in your thesis (photos, tables, etc) will not be made accessible within Otago University Research (OUR) Archive. A note will be applied to indicate that certain items have been suppressed, e.g. "This image has been removed for copyright reasons".

Your rights as the author

Copyright ownership

At the University of Otago the copyright for material produced by you as a student remains with you (see the [Intellectual Property Rights of Graduate Research Students Policy](#)^{viii}), unless agreed otherwise.

Sharing your thesis

Select the level of public access to your thesis when you deposit the thesis into OUR Archive. The default is 'all rights reserved', i.e. no-one can copy your work without requesting your permission to do so beyond the limits allowed by law for [fair dealing](#). Alternatively you can choose a [Creative Commons licence](#)^{ix}, which allows people to use your material in ways specified by you, the most common being [attribution](#). Please consider the level of access you wish to provide the public long-term, as once applied this cannot be altered.

Supplementary material

The Library can enable access to any [supplementary material](#) associated with your thesis. The Library can also apply licence conditions, such as might be required for software or research data.
